On one side, many are the advantages of arbitration over court litigation when intra-corporate disputes are at stake. On the other side, however, arbitration raises several issues as regards the arbitrability of (all) intra-corporate disputes, the protection of minority shareholders, confidentiality and third parties' rights. One outstanding keynote speaker and 10 young professionals coming from the four corners of Europe will discuss the pros and cons of arbitrating intra-corporate disputes.
